

For the purpose of revision, amendment and correction of the Electoral Rolls for Azad Jammu and Kashmir Legislative Assembly prepared in 2016, in pursuance of Section 22,26 of the Azad Jammu and Kashmir Elections Act 2020, the Election Commission AJ&K has been pleased to issue the following time schedule:-

1.	All administrative arrangements including the supply of the Electoral Rolls 2016 updated till now by NADRA and printed forms prescribed under the AJ&K Elections Rules 2020 shall be completed before	15-01-2021
2.	Verification, addition and deletion of the entries with in the manuscript of draft electoral rolls and provision of soft data by the Registration Officers to the Election Commission.	20-01-2021 to 09-02-2021
3.	Verification, addition and deletion of draft electoral rolls by NADRA and provision of corrected electoral rolls (Preliminary Electoral Rolls) to Election Commission.	10-02-2021 to 22-02-2021
4.	Publication of the Preliminary Electoral Rolls with general public notice inviting claims for enrollment and objections against any existing entries or applications for corrections.	23-02-2021
5.	Presentation of claims for enrollment and objections against existing entries, or applications for correction of existing entries.	24-02-2021 to 10-03-2021
6.	Hearing and decisions by the Revising Authority on claims for enrollment and objections, or applications for correction.	11-03-2021 to 17-03-2021
7.	Transmission of decisions by the Revising Authority to the Registration Officer concerned.	18-03-2021 to 19-03-2021
8.	Incorporation of decisions of Revising Authority by the Registration Officer in the Electoral Rolls and provision of the soft data to Election Commission.	20-03-2021 to 22-03-2021
9.	Publication of Final Electoral Rolls by the Registration Officers after incorporating the decisions by the Revising Authority with general notice to the public.	01-04-2021


