

06	Last date for withdrawal of candidature.	30-10-2019 Before 2:30 pm
07	Publication of the list of contesting candidates.	30-10-2019
08	Allotment of Symbols.	31-10-2019 (9:00 am to 12:30 pm)
09	Publication of final list of contesting candidates showing the Symbols allotted to them immediately after allotment of symbols.	31-10-2019
