In supersession of Notification No. PS(CEC)/19023-30/2016, dated 30-07-2016 and in pursuance of Sub-Section (2) of Section 5 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, and Rules 3, 4 & 14 of the Azad Jammu and Kashmir President (Election) Rules, 1985, the Chief Election Commissioner Azad Jammu and Kashmir shall conduct election to the Office of the President of Azad Jammu and Kashmir on **16-08-2016**, in the Lodging Hall, of the Azad Jammu and Kashmir Legislative Assembly, Muzaffarabad as per programme set out below and for that purpose, is pleased to appoint Mian Naeemullah Secretary Azad Jammu and Kashmir Election Commission to be the Presiding Officer:-


01	Filing of nomination papers with the Chief Election Commissioner/ Returning Officer on <u>11th August, 2016</u> from 10.00 a.m to 12.00 noon in his office, at House No.1, Near Azad Jammu & Kashmir Legislative Assembly, Muzaffarabad.
02.	Scrutiny of nomination papers by the Chief Election Commissioner/ Returning Officer, on the same day at the same place immediately after the filing of nomination papers.
03	Withdrawal of nomination papers on <u>12-08-2016</u> by 12.00 Noon .
04	Polling on <u>16-08-2016</u> from 10.00 a.m to 3.00 p.m to be immediately followed by the counting of votes by the Chief Election Commissioner.

2. For the holding of the aforesaid election, the Chief Election Commissioner, under Rule 13 of the Azad Jammu and Kashmir President (Election) Rules, 1985, has requested the President of Azad Jammu and Kashmir to duly summon members of the AJ&K Legislative Assembly and AJ&K Council, entitled to vote for the election to the Office of the President, to assemble in joint sitting on **16-08-2016** at the aforesaid place and time to record their votes.
