

In exercise of the powers conferred upon it under Article 50 (7) of the Azad Jammu and Kashmir Interim Constitution, 1974 and all the powers enabling it under Section 125-A (3) of the Azad Jammu and Kashmir Elections Act, 2020 and Rule (13) of the Azad Jammu and Kashmir Local Government Election Rules 1983, the Azad Jammu and Kashmir Election Commission is pleased to hold and conduct Local Governments Election during the Year 2022 against the general seats of the Local Councils and the Wards of the Urban Areas in Azad Jammu and Kashmir which have already been duly constituted and delimited as notified under the provisions of Azad Jammu and Kashmir Local Government Act, 1990 and the Rules made there under in pursuant to aforesaid laws.

2. Consequent upon the Azad Jammu and Kashmir Election Commission while exercising the powers conferred upon it under section 37 of election act 2020 is pleased to revisit/alter the schedule for election activities issued vide Notification No.EC/S/9648-9799/2022 dated 11-08-2022 and calls upon the voters duly enrolled in the constituencies of the Local Councils to elect their representatives as per the following **Schedule** of election activities:-

2.	Scrutiny of nomination papers by the Returning Officers concerned.	22 nd of October 2022
3.	Publication of list by the Returning Officer of validly nominated candidates.	22 nd of October 2022 (soon after scrutiny)
4.	Last date for filing of appeals before the Appellate Tribunal against rejection of nomination papers.	25 th to 26 th of October 2022 till 2:00 p.m.
5.	Hearing and decisions of appeals by the Appellate Tribunals concerned.	26 th to 28 th of October 2022
6.	Last date for withdrawal of candidature.	29 th of October 2022 till 2:00 p.m.
7.	Publication of the list of Contesting Candidates.	29 th of October 2022
8.	Allotment of symbols to the contesting candidates.	31 st of October 2022
9.	Publication of final list of contesting candidates showing the symbols allotted to them immediately after allotment of symbols.	31 st of October 2022
10.	Date of polling.	27th of November 2022 From 8:00 a.m. till 5:00 p.m.
11.	Consolidation of the results of the election by Returning Officers concerned.	Soon after the close of polling on receiving results from the Presiding Officers.
